**Ministry of Emergency Situations of the Republic of Uzbekistan (MES) is the central body of public administration which manages and coordinates works in the sphere of civil protection, prevention and liquidation of ES caused by emergencies, catastrophes and acts of God.**

## **MES Main Tasks**

- ▣ establishment and maintenance of the national system of warning on and actions in case of ES;
- ▣ coordination of efforts of ministries, agencies, Council of Ministers of the Republic of Karakalpakstan, oblast, urban and district administrations on protection of population and national treasures, prevention and liquidation of emergency situations caused by catastrophes and acts of God;

## MES Main Tasks

- managing works on liquidation of major emergency situations, establishment and ensuring of preparedness of necessary forces and means;
- arranging development and implementation of target and scientific and technical programs aimed at ES prevention, protection of population and territory of the country, and increased sustainability of economy objects' functioning in case of ES;

## MES Main Tasks

- Arrangements for preparation of population, officials and NSES divisions to actions in emergency situations;
- arrangement of international cooperation on issues within the Ministry's mandate.

## MES of the Republic of Uzbekistan

■ in due order and within its mandate takes decisions obligatory for execution by ministries, agencies, associations, Council of Ministers of the Republic of Karakalpakstan, oblast, urban and district administrations, enterprises, institutions and organizations independent of their ownership form, coordinate works on civil protection, prevention and liquidation of ES, catastrophes, and performs control over execution of such;

## Management of the civil protection is laid on:

**in the Republic of Uzbekistan** – Prime-Minister of the Republic of Uzbekistan;


**in the Republic of Karakalpakstan, oblasts, cities and rayons** – Chairperson for the Council of Ministers of the Republic of Karakalpakstan and mayors of relevant territories;


**in ministries, agencies, associations, enterprises, institutions and organizations** - ministers, chairpersons of public committees and boards of associations, directors and heads of enterprises, institutions and organizations.
