## **CLOUD BURST/LANDSLIDES IN UTTRANCHAL**

Cloud burst/ Landslides Situation:

- 28 bodies recovered. Bed weather- raining heavily, Helicopter could not land at site.
- Medical Teams, Relief, ITBP Coy and Army Column working on the site.
- Relief material moved by road.

Report received on 11.8.2002, that there was a cloud burst in the area of Tehsil Ghansyali in Distt. Tehri. The information has been obtained from Govt. of Uttranchal and the position is as under :-

- 1. The villages affected are Marwari, Kotsisham, Matgoan and Agonda. State Government has confirmed 28 deaths. Marwari (10), Kotsisham (3), Matgoan (4) and Agonda (11). in Ghansali area. About 6 to 7 villages are cut off and there is apprehension that causalities may be more. 5 persons have reported injured so far. The other affected villages are Koti, Jhala, Urni and Pinswar.
- 2. There are also reports of land -slides in Uttarkashi at Tahsil Bhatwari, near village Siror, where 4 persons feared dead, but this has not yet been confirmed by the State Government and they have yet to get feedback.
- 3. One Army column and one ITBP Coy from Gochar have been moved in area for recce and rescue and have reached now. One ITBP Coy has also been moved from Matali to Uttarkashi and feedback is awaited.
- 4. We have spoken to Chief Secretary Uttranchal and have been in touch with the Additional Chief Secretary, who is coordinating the operations and Resident Commissioner at Delhi.
- 5. As desired two Helicopters have been arranged from the Air Force and ACS (Ops) Mr. Gokhle has confirmed.
- 6. One Helicopter was to reach Gorkha Training Centre Helipad at 0730 hrs on 12.8.2002 for recce and to make rapid assessment of the ground situation, but is not able to land because of bad weather. Another MI 17 Helicopter for carrying relief for air- dropping and evacuation took off at 1202 hrs. on 12.8.2002, but could not land as it is raining heavily.

- 7. We have already sensitized Air Force/ Army that besides recce, they may be required to undertake joint operations for evacuation or for sending down troops for rescue operations on ground and for air dropping. They have assured there will not be any problem.
- 8. Uttranchal Govt. has setup wireless centers around the area nearest of which is about 6 Kms from the site of the disaster. The base camp has been made at Ghansyali by the State Government. The State Government has moved relief by road.
- 9. For old Trhri town, Chief Secretary informed that DM and SP have left for site, and situation so far is not serious. We are awaiting for their feed back.
- 10. State Govt. has sent medical teams, which have reached by now alongwith the relief teams. For the present, the Chief Secretary, Uttranchal has informed that they do not require medical or any other assistance from Govt of India except mentioned above.
- 11. MHA is constantly monitoring the situation and coordinating the Central efforts.
