Minutes of the Brainstorming Meeting Asia Regional Task Force on Urban Risk Reduction (RTF-URR)

23 and 24 January 2008 Kobe, Japan

PURPOSE OF THE MEETING

UN/ISDR recently started functioning in Kobe with a new office nestling in the same premises where ADRC, UNCRD, IRP Secretariat are also located. In addition to bringing in synergy in disaster risk reduction in the region, this office is also proposed to act as a focal point for the functioning of the RTF-URR in the context of ISDR Thematic Platform on Urban Risk Reduction. It is recognized that many organizations in the Asia Pacific region are doing remarkable work in risk reduction regime but may not be noticing it mutually or able to find common platform to work collectively. Moreover, donors also pointed out to synergize and facilitate the work of various institutions and promote joint local/national/regional activities in URR. Hence, the several-fold purposes of the meeting were to:

- 1) Facilitate cooperation among agencies;
- 2) Share information and minimize overlap;
- 3) Promote joint local/national/regional activities; and
- 4) Promote action to take advantage of ongoing priority initiatives globally and regionally.
- 5) Discuss feasibility of establishing a Regional Task Force on Urban Disaster Risk

The brainstorming meeting provided an opportunity for the participants to inform their respective work areas, further discuss with other participants to engage wider discussion, explore possibility of partnership, get to know new avenues and priorities and finally ways to optimize benefits arising out of new RTF-URR initiative.

MAJOR DISCUSSION

The key points of discussion from the two-day meeting held in ADRC & UNCRD in Kobe are as follows:

(1) RTF will facilitate knowledge and information exchange, and will act as a platform of information sharing but will not implement any specific project by its own - donors already identified gaps in synergies which need to be addressed immediately. Hence RTF may also help linking possible networking/funding opportunity to those projects which one or many members will be implementing individually or jointly.

(2) Specific projects will be conducted by the participating organizations and institutions, and will be reported to the RTF for its wider dissemination.

(3) RTF will work in line with the HFA priorities of action for the region. National reports are being prepared by June 2008 and regional (including thematic) reports by August 2008, which will be fed into the Global Assessment Report to be ready by December 2008. The final version of the Global Assessment Report will be presented at the 2nd Global Platform meeting in June

2009. One or two members may take up the task of compiling all information available for regional report on urban risk. Thematic reports are already being prepared and there is a concrete proposal to prepare 'Regional Report of all good initiatives' targeted this year. The Asian Ministerial Conference held in Delhi last year also felt that mapping of activities of the institutions in Asia Pacific region is required and ADB might fund this project.

PROPOSED ACTIVITIES:

It was suggested that the activities of the RTF-URR may be categorized in following key working themes. Each of these themes represents wide range of activities and lead organizations are proposed to take responsibilities to initiate appropriate actions.

- 1. Policy and Advocacy
- 2. Knowledge Management
- 3. Promoting synergies and cooperation

Some of the suggested activities are as follows:

In immediate future:

- Contribute to HFA progress reporting on urban risk (thematic report)
- Mapping of urban risk and resilience in the Asia Region (as a contribution/input to the Regional Mapping Initiative which is being carried out under the auspices of the Expanded ISDR Asia Partnership with potential funding from ADB)
- Comments on the: Report on the Baseline Status of DRR in Asia and the Pacific (especially a report in urban context covering important vulnerable cities the region)
- Comments on the : Technical/ policy note on building codes and land use management
- High level advocacy through 'key messages' to influence policies
- To boost/enhance immediate actions with the support from the UN/ISDR, Kobe office.
- Develop a TOR for the Regional Task Force on Urban Disaster Risk and develop mailing list of Task Force members.
- Prepare a brochure on the Task Force and its objectives/activities.

In near future:

Three major activities (1) Networking and knowledge sharing (presentations and participation in the major global and/or regional forum) (2) Developing knowledge products (knowledge repository, training and capacity building programs (3) Initiative and/or provide link to country activities (country specific actions and dissemination), (4) Regional policy paper on urban disaster risk (based on GFDRR Technical Notes and EMI policy paper)

In Long term:

Influence urban policy and programmes of various vulnerable countries to enable and strengthen urban risk reduction and contribute to building resilient city environment.

PROPOSALS SHARED BY THE CORE MEMBERS:

These activities listed will be taken up by the individual organizations or in partnership with some members or other organizations. This list is not comprehensive and members may add more activities as per the discussions held in Kobe. Their proposals may not be initiated by the RTF but will be linked through RTF for wider dissemination.
