#### Minutes of the 3<sup>rd</sup> meeting ASIA REGIONAL TASK FORCE ON URBAN RISK REDUCTION 15 May 2008, Kobe

**Participants** UN/ISDR, ADRC, IRP, UNEP, UNCRD, Kyoto University, Kobe University, JICA

#### Main Issues of Discussion

It was reiterated that the Task Force is not an implementing body, but more a facilitator, coordinator and synergy developer. The Task Force promotes urban disaster risk reduction in on-going key activities in Asia.

A Preliminary Draft Workplan Jan 2008 – March 2009 of the RTF-URR, which includes description and timeframe of activities proposed in the previous discussions among the members of the RTF-URR (please see the annex 2), was introduced. The main points discussed are the following (please see the immediate follow-up actions for the details):

# a. Development of the Guideline "Words into Action for Local Governments for the Implementation of the HFA" and of a training programme for local government officials.

Draft Table of Contents, which is in line with the existing HFA Words into Action, was shared with the participants for discussion. It was agreed that Kobe University and UNEP Osaka will contribute to developing the annotated table of contents based on the draft table of contents proposed, and will also make comments on the draft ToR for a consultant for the development of the "Words into Action for Local Governments for the Implementation of the HFA".

The consultant (to be identified) should review various documents including SLAP (Strategic Local Action Plan), which was introduced in Indonesia (the local government of Indonesia and UNDP were involved in that process).

#### b. Collaboration with CITYNET

Meeting was informed of the outcome of the CITYNET Disaster cluster meeting in Makati 13 May 2008. In that meeting, collaboration between CITYNET and Urban Task Force was proposed. The areas of cooperation include collection of sound practices on DRR and CCA by CITYNET members, review of the risk profile of CITYNET members, use and testing of the "Local Words into Action" document by CITYNET steering committee in October 2008 in South Korea, and a possible partnership with JICA on DRR training for cities. Follow-up with CITYNET is necessary to discuss details of these activities.

#### c. Involvement in the 3<sup>rd</sup> Asia Ministerial Conference as the RTF-URR

A couple of modalities for the RTF-URR's contribution to the 3<sup>rd</sup> Asia Ministerial Conference to be held in Kuala-Lumpur, Malaysia in December this year were introduced; organizing a technical session on URR including leading a segment in the plenary, or organizing a side event or pre-event on URR. It was agreed that Chair, Vice-chair, and UN/ISDR Hyogo Office will review these options and come up with a draft plan.

#### d. RADIUS Follow up project

Considering the recent Earthquake in China, it was suggested that a follow-up project for "RADIUS (Risk Management Tools for Diagnosis of Urban Areas against Seismic Disasters" as one of concrete activities of the RTF-URR. RADIUS was the project during the IDNDR and applied to several cities including Zigong, China. It was agreed that Chair draft a concept note by the end of May. The plan should consist of two components: the 1<sup>st</sup> phase for the immediate plan to assess the impact of RADIUS in China and the second phase expanding its impact assessment to several cities.

## e. Contribution to the HFA Implementation Status Report on Urban Risk Reduction in Asia

As the input from the RTF-URR, a short paper (1-2 pages) will be drafted and submitted to be included in the ISDR Global Assessment Report. Separately from this short input paper, a publication (approx 20 pages) on regional URR will be produced as one of the RTF-URR activities and aimed at presenting it at the 3<sup>rd</sup> Asia Ministerial Conference. Members of the RTF-URR will contribute by providing inputs.

#### f. Production of a Good Practice Publication on URR

UN/ISDR secretariat has been producing a series of good practice publications on DRR. As one of these publications, a concept note on good practice publication on URR will be drafted by the Chair. .Finalization of this publication will be targeted at the Ministerial Conference. A consultant will be used for the compilation of these good practices together with compilation of inventory of URR activities.

#### Identification of upcoming events
