HOW are the guidelines structured

The guidelines reflect the Hyogo Framework structure, and include:

Five Action Areas:

1. Ensure that Disaster Risk Reduction is a National and Local Priority with a Strong Institutional Basis for Implementation
2. Identify, Assess And Monitor Risk And Enhance Early Warning Systems
3. Use knowledge, innovation and education to build a culture of safety and resilience at all levels
4. Reduce the underlying risk factors
5. Strengthen Disaster Preparedness for Effective Response at all Levels

For each Action Area - 3 to 4 proposed 'getting started' activities;

For example

Action Area 1:

Ensure that Disaster Risk Reduction is a National and Local Priority with a Strong Institutional Basis for Implementation

- Proposed 'getting started activities' for this action area:

- 1.1 Evaluate legal, institutional, and policy framework
- 1.2 Multi-Stakeholder Dialogue
- 1.3 Establish Disaster Risk Management Vision, Policy and Plan
- 1.4 Institutionalize and Mainstream Disaster Risk Reduction into Everyday Functions and Operations and Long-Term Plans

Getting Started Steps

- Obtain executive and organizational support for the review
- Organize an interdisciplinary team to undertake the review
- Gather information through research of documentary sources—laws, executive orders, regulations, policies, strategies, plans, resources, and institutions and institutional arrangements for disaster risk reduction, preparedness, response and recovery.
- Conduct structured interviews of government officials and other key stakeholders including local disaster researchers
- Review past disaster experiences and lessons learned as revealed in previous studies
- Identify strong and weak aspects of the existing systems
- Identify relevant experiences from other States which might be adapted and implemented
- Identify improvements which can be made, opportunities for learning and strengthening existing systems, and collaboration with international, national, and local entities

Obstacles and impediments

- May need to overcome some initial reluctance toward perceived criticism or self-criticism that is implicit in an assessment or evaluation
