

COVID-19 Countermeasures in ADRC Member Countries

Desk Survey from Online Resources

(As of May 20, 2020: This report is regularly updated to reflect latest information)

1. Basic Policy

National governments' basic policy in fighting Covid-19 includes containing, mitigating, and managing its and economic impacts (Table 1). Specific countermeasures in implementing the basic policy vary among countries due to differences in the following: 1) preparedness of the health systems, 2) demographics, e.g., percentage of elderly and poor, 3) population density, 4) testing capacity, and 5) cultural, social, and political dynamics.

Containment	BR	Border Control: restriction of foreign entries to the country
	L	Lockdown: full (nationwide) or partial lockdown (region or city)
	MR	Movement Restrictions: behavior change (e.g., stay home)
Mitigation	HS	Strengthening of Health System: hospital beds, ventilators, PPEs, treatment
	TT	Tracing and Testing: cluster tracing, PCR testing
	SD	Social Distancing: cancelation of group events
	M	Wearing of Mask: promoting use masks or distribution of masks
	V	Vaccine research and trials: development and application of vaccine
Economic Support*	CA	Cash Assistance to citizens: cash & relief assistance to residents or those affected
	EA	Economic Aid to businesses: economic aid packages, tax relief, etc.

* Some countries borrowed money from lending institutions (e.g., International Monetary Fund, World Bank, and Asian Development Bank) to support the economy.

3. Role of Disaster Risk Management (DRM) Agencies

Respective Disaster Risk Management (DRM) Agencies of ADRC Member Countries mostly play key roles in preventing spread and managing the impact of Covid-19. DRM agencies (ADRC's counterparts) share lessons and technologies in disaster preparedness, response, and recovery. One of the notable best practices in disaster management is the utilization of mobile apps in tracing and assisting victims. In view of this, DRM agencies either modified or provided inputs in developing a new **mobile app on Covid-19**, where functions include providing basic information, contact tracing, and self-assessment. Table 3 shows the roles and initiatives of the DRM agencies in the fight against coronavirus as indicated in their respective websites. It also shows the names of mobile apps as well as links about the details.
